

# Lemon Bay Golf Club FACT SHEET 2020/2021

## About the course ...

- Lemon Bay Golf Club consists of an 18 hole golf course (par 71), located on County Rte 775 (Placida Road), on the Cape Haze peninsula, minutes from Boca Grande.
- Lemon Bay is an Audubon certified golf course. Originally one of only 165 in the world and 25<sup>th</sup> in the state of Florida. Anhinga and Cormorant are everywhere, as are Blue and Green Heron, and Egret of all sizes. We also have a beautiful resident family of Bald Eagles who fledge eaglets each spring.
- In 2019 we celebrate our 30<sup>th</sup> anniversary. We welcomed 2017 with a new clubhouse.
- A fun filled tournament schedule allows golfers of all skill levels to enjoy the camaraderie of the membership.
- The Club sponsors a growing list of activities for members, In addition to tournaments, weekly men's day, ladies' day, and pickup games are available.

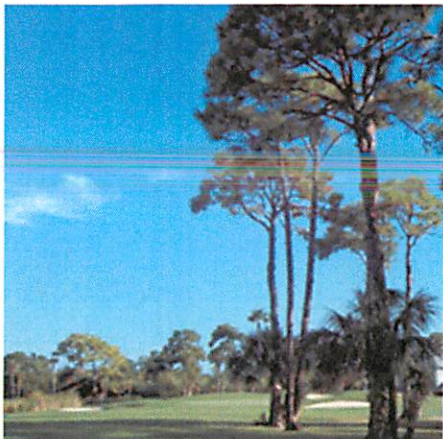
## Types of Membership:

- **Equity membership.** Price to join is \$60,000. \$100 of the cost is for a share of stock.
- **Trial membership.** A one year trial membership is available for a \$1,000 non-refundable deposit (may be applied to initiation fee when converting to an equity membership). Dues & annual fees must be paid for the 2020/2021 fiscal year (approx. \$8,800). *A member sponsor must initiate the membership process.*
- **Associate/Preretirement membership.** *Prospective members under age 62 may join for a \$60,000, reduced dues, and payment plan. Conversion to an equity membership must be made by age 65, or after 7 years whichever occurs first.*
- **Legacy program.** *Children of existing members/stockholders may qualify for a reduced cost to join as well as reduced dues, and payment plan. Please ask for details.*

## How do I join?

- Applying for membership requires an executed Application and Subscription Agreement, signed by two member sponsors in good standing (one for a trial membership), along with letters of recommendation from each sponsor. Each applicant must be approved by the Membership Committee and the Board of Governors
- Dues for the current fiscal year are payable and may be paid annually, semi-annually, or quarterly if desired
- All members are responsible for infrastructure and capital building assessments
- All fees other than stock and assessments are subject to 7% Florida sales tax
- A Florida corporation whose stockholders are members of the Club, Lemon Bay is private during the most desirable winter months of October through mid-May. The course is open to the reciprocal courses for non-member play during the summer months to help offset dues.
